4. Property of the Trust:

10. Meeting of the Trust

 - 7. The President of the Trust is empowered to investe the amounts belonging to the trust in debentures, Fixed Deposits, National Savings Certificates and to the trust.
 - 8. The President shall have power to enter into contracts on behalf of the trust or resind the same.
 - 9. To receive collect and enforce recover of all moneys due or payable to the trust and to pass receipts or grant discharg in respect of the same.
 - 10. To sign verify, any appeal, application or petition on behalf of the trust for being presented before any court or authority and to engage advocates in this behalf.
 - 11. To prosecute, institute or defend legal proceedings instituted by or against the trust, when so sued.
- 12. To apply properties and funds of the trust for the objects of the trust, in such manner of the deem fit.
- 13. To obtain on transfer for the benefit of the trust institutions Land and Building/Equipment/Library which are already started by any other trust.

- 15. Generally to do such further acts as may be necessary for fully and effectively achieving the object of the trust.
- 16. Duration of the Office of the Trustee:
 - 1. The founder trustees shall be trustees for life.

 In the absence of nomination by the deceased trustee the surviving trustee shall nominate one other person as a trustee for life along with the surviving trustees.
