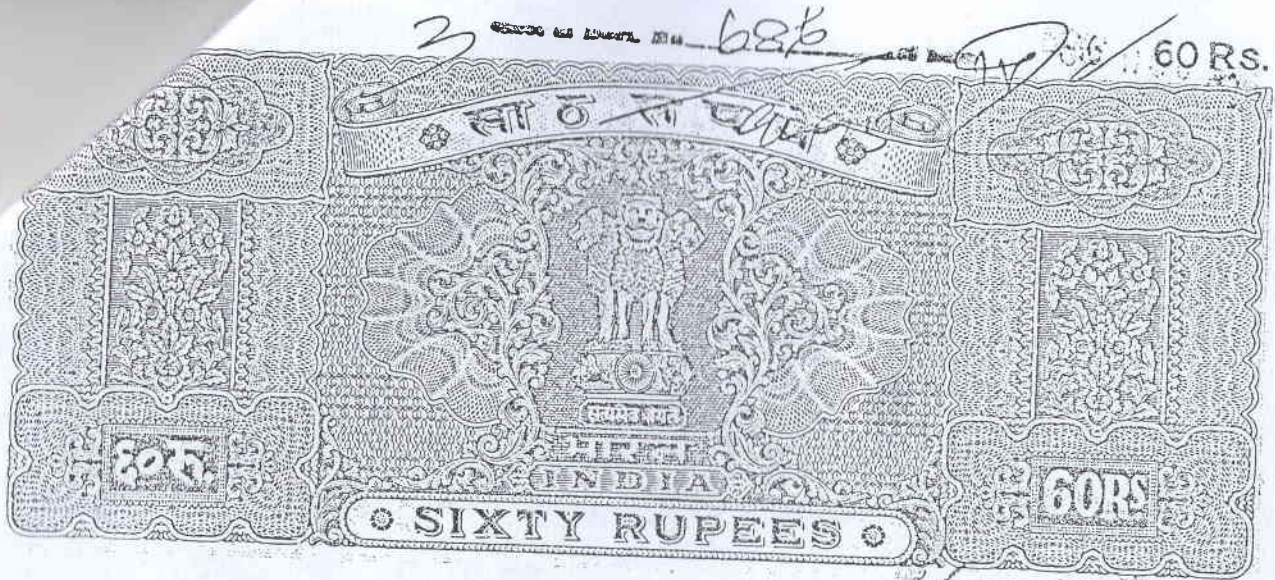

4. Property of the Trust :

1. The contribution of Rs.1,000/- each made by the founder trustees at the inception of this trust.
2. Contributions received from persons or bodies either by way of donations, subscriptions or legacy for the benefit of the trust or its programmes.
3. Funds realised by the trust by arranging Dramas, Charity Shows, etc., for the benefit of the trust.
4. Properties acquired in the name of the trust in any manner from any person, charitable Institution, Municipality, State or Central Government or other body corporate.

5. Management of the Trust :

1. The management of the trust is vested jointly in the two founder trustees, Shri. C.Mallikarjuna is designated the president of the trust and Smt. B.Kalpana is designated the Secretary of the Trust until and unless they voluntarily relinquished being trustees of the trust.

6. Powers of the President :

1. The President is empowered to appoint a manager or correspondent to manage the day to day affairs of the trust on such terms as to remuneration etc., as may be decided by. The President is empowered to make all appointments in the institutions belonging to the trust on such terms and conditions as the President may deem fit and proper.
2. All persons employed by the trust shall function directly under the President and shall be bound by the Directions given by the President.
3. The president shall have power to suspend or dismiss any of its employees.

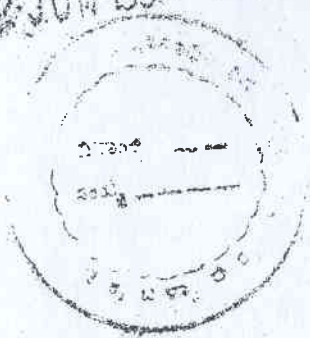

1. The accounts of the trust shall be properly and correctly maintained by the president of the Trust. The accounting year shall be from the first of April to the 31st of March of each calendar year. The accounts of the trust shall be got audited by a Chartered Accountant and a financial statement prepared in this behalf shall be presented at a meeting of the trustees to be held every year.

9. Bank Account :

1. Bank Account or accounts in the name of the trust on in the name/names of the institutions managed by the trust can be opened in any scheduled commercial Banks and such accounts shall be operated by the president of the Trust, or such other person authorised by him.

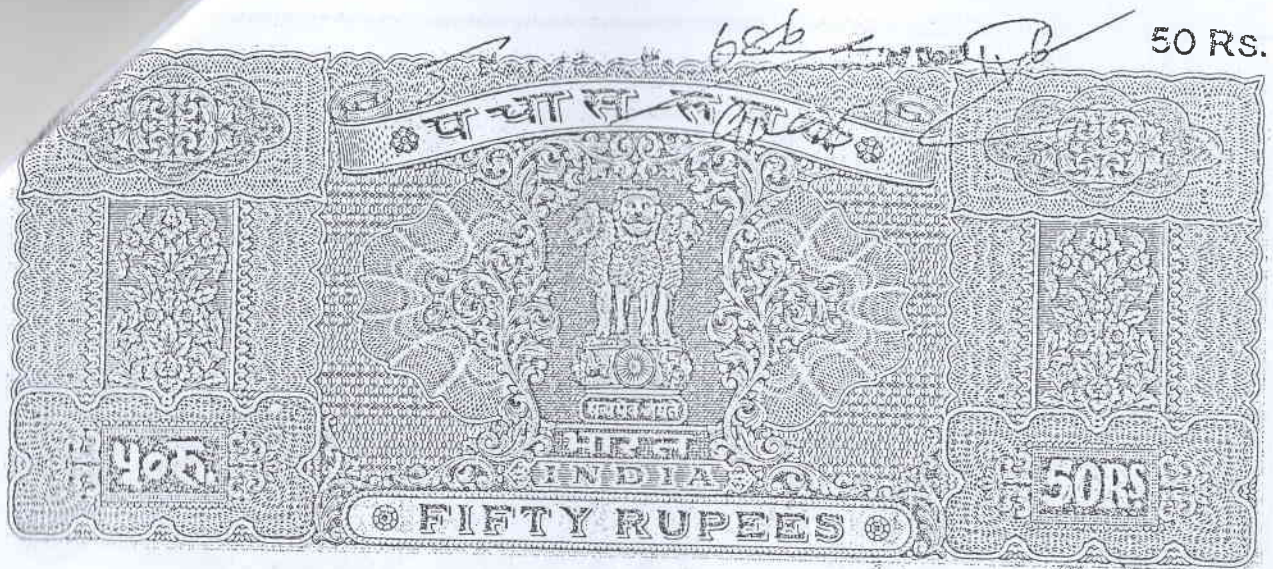

10. Meeting of the Trust :

13. Amendment to the deed of Trust :
1. The provisions of this trust deed may be altered or amended by a decision of the two founder trustees arrived at in unanimity. Immediately on passing of such resolution the trust deed shall stand amended as per terms of the resolution.
14. Provision in the event of determination of the Trust :
1. In the event of determination of this trust for any reason what so ever, the founder trustees or the survivor of them, shall make over the funds and properties of the trust to any other trust or institution having similar objects as contained in this trust deed.

15. Powers of the President : (Cont.) ...from Page (4) Point (6)

7. The President of the Trust is empowered to invest the amounts belonging to the trust in debentures, Fixed Deposits, National Savings Certificates and Such other monetary instruments as may be beneficial to the trust.

8. The President shall have power to enter into contracts on behalf of the trust or rescind the same.

9. To receive collect and enforce recover of all moneys due or payable to the trust and to pass receipts or grant discharge in respect of the same.

10. To sign verify, any appeal, application or petition on behalf of the trust for being presented before any court or authority and to engage advocates in this behalf.

11. To prosecute, institute or defend legal proceedings instituted by, or against the trust, when so sued.

12. To apply properties and funds of the trust for the objects of the trust, in such manner of the deem fit.

13. To obtain on transfer for the benefit of the trust institutions Land and Building/Equipment/Library which are already started by any other trust.

14. To organise programmes for mobilising funds for the programmes of the trust.

15. Generally to do such further acts as may be necessary for fully and effectively achieving the object of the trust.

16. Duration of the Office of the Trustee :

1. The founder trustees shall be trustees for life. After the death of any one of the trustees any person nominated by the deceased trustee shall occupy the position of the trustees so nominating. In the absence of nomination by the deceased trustee the surviving trustee shall nominate one other person as a trustee for life along with the surviving trustees,

17. Co-option of trustees :

1. The Co-opted trustees may at any time be removed without notice by a unanimous resolution of the founder trustees only.
2. Any vacancies in the post of the nominated trustees can be suitably filled if necessary by the founder trustees. The nominated trustees shall have no power of voting.

18. Area of operation of the Trust :

1. The area of operation of this trust shall be the State of Karnataka. However the founder trustees could enlarge the area operation to any other part of India by a joint decision of the founder trustees.

19. Removal of difficulties :

1. Any doubt arising in the interpretation of the trust deed shall be removed by the unanimous decision of the founder trustees.
